RE-ENROLLMENT FOR CURRENT STUDENTS & APPLICATIONS FOR NEW STUDENTS

Enrollment applications open for New Student and Returning students.	January 8, 2024	<ul style="list-style-type: none"> • \$250 Tuition deposit (non-refundable) due at the time of re-enrollment. • \$250 new-student application fee (non-refundable, not applied to tuition) due at time of application to cover screening costs
Tuition Assistance Application through FACTS	January 8, 2024 - Feb 28, 2024	<ul style="list-style-type: none"> • Please remember that you must first complete the re-enrollment and/or new-student application BEFORE the Tuition Assistance Committee (TAC) will evaluate your Tuition Assistance assessment. • Application for FACTS requires a \$40 processing fee • Go to https://www.torahday.org/financialaid for the FACTS Grant and Aid online form • TDSA will email Enrollment Contracts, which will include tuition amounts, no later than March 25, 2024.
DEADLINE for RE-ENROLLMENT student and New Student from a Re-enrolling family	February 6, 2024	<ul style="list-style-type: none"> • \$250 Tuition deposit (non-refundable) due at the time of re-enrollment. • New Student Application fee \$250 (non-refundable).
LATE RE-ENROLLMENT FEE APPLIED	February 7, 2024	<ul style="list-style-type: none"> • Non refundable \$250 late fee for those applying after February 6, 2024. This will not apply toward tuition.
TUITION ASSISTANCE APPLICATION (through FACTS) DEADLINE	February 28, 2024	<ul style="list-style-type: none"> • FOR RETURNING FAMILIES ONLY: Tuition assistance assessment will increase by a minimum of 15% for families submitting incomplete or late applications for tuition assistance.
ENROLLMENT CONTRACTS SENT OUT	March 25, 2024	<ul style="list-style-type: none"> • Enrollment contracts (for those completing their tuition assistance application on time) will be sent out with tuition decisions no later than March 25, 2024.
DEADLINE TO SUBMIT SIGNED ENROLLMENT CONTRACT AND FINALIZE TUITION PAYMENT PLAN	April 15, 2024	<ul style="list-style-type: none"> • Deadline to submit signed enrollment contract and to finalize ParentLocker payment details. • After this time, a \$500 non-refundable late fee will be charged. This fee is not applicable to tuition.
PARENTLOCKER PAYMENT PLANS COMMENCE	July 20, 2024	<ul style="list-style-type: none"> • Initial '24-'25 tuition payment must be made no later than this date. Payments outside of accepted ParentLocker payment plans will be assessed a \$25 transaction fee.

New and Returning Students from Current TDSA Families:

Please log in to ParentLocker to fill out the application, found in the menu under 'School Forms'. A re-enrollment, tuition deposit of \$250 per student for returning students and \$250 non-refundable fee for new students is payable at the end of the form. The deadline is **February 6, 2024 for both returning and new students from current TDSA families**. *After February 6, 2024 a late fee of \$250 will be incurred.*

Completing enrollment by February 6, 2024 will reserve your child's place in school next year. An accurate enrollment count is essential in building our budget and providing our faculty with employment contracts in a timely fashion.

Families New to TDSA:

Applications for students from families new to TDSA are available after **January 8, 2024**. An application fee of \$250 is payable at the end of the form. Tuition Assistance

At TDSA, we consider Jewish education a top priority. A TDSA education is both an opportunity and an investment in your child's future, and we are committed to offering assistance to families who have qualified needs.

Currently enrolled families: Please see the chart shown above for deadlines.

Families new to TDSA: Application for tuition assistance must be submitted within 2 weeks of applying to TDSA. All deadlines will be strictly enforced. Minimum tuition is \$6,063, exclusive of application fee, per child and family building fund obligation. Your tuition assessment will be between \$6,063/child and full tuition, exclusive of application fee and building fund.
